#### WAGES OF BAGGAGE INSPECTORS

**Mr. Les Benjamin (Regina West):** Mr. Speaker, in view of the fact that commissionaires issuing parking tickets at the parking lots at Dorval and Mirabel Airports are paid over \$6 an hour and the security screeners are paid around \$4 an hour, will the Minister give greater priority to those who screen passengers, baggage, and hand luggage, over those who issue parking tickets?

**Hon. Don Mazankowski (Minister of Transport):** Mr. Speaker, as I indicated in an earlier answer, the Solicitor General and I are developing a comprehensive enhanced security program for all airports which will cover the longer term. In the immediate term there are some measures which we are implementing. We are improving the system all the time.

I want to assure the Hon. Member that I will be calling in representatives of the airlines next week, as well as representatives of Burns Security Services and other security agencies, to see what steps might be implemented to address this very serious problem.
