PUNISH, NOT EVICT.

Ohio's Attorney-General Will Sue Anti-Trust Law Violators.

Columbus, Ohio, May 18.—In conformity with a declared policy of administering punishment rather than attempting to oust companies that have violated the anti-trust laws, Attorney-General Ellis today filed in the Franklin County court a suit against the Standard Oil Co.

The defendants are the Vacuum Oil Co. of Rochester, N.Y., and the Manhattan Oil Co. of Lima, Ohio.

The Vacuum Oil Co. is charged with failure to obey a law which requires foreign companies to report to the secretary of state. The Vacuum Oil Co. is alleged to owe the state \$129,000.

The suit against the Manhattan is for failure to make reports and omitting to pay annual fees.

BURGLAR WAS INJURED IN "CRACKING" A SAFE

Salisbury, Md., May 18.—A gang of five men blew open the safe of the Baltimore & Chesapeake & Atlantic Railroad passenger station here early today with nitroglycerine, but secured no cash.

The safe was blown open by a piece of iron from the same and badly hurt. The others carried him about two miles to a farm house, where they left him unconscious. Three of the fugitives were later captured.

SERVE HOME MARKET FIRST
COMPULSION FOR FISHERMEN

Some Striking Recommendations, Along Lines of Government Ownership, in Provincial Report.

The annual report of the provincial department of fisheries, just issued, contains some recommendations of interest and importance. A conference with a view to establishing uniform regulations for Canada and the United States covering fishing privileges in the great lakes, is urged as an imperative necessity on the ground of heavy depletion of the fish supply.

With great emphasis, also, is advocated making it a compulsory duty of Ontario fishermen to supply the home market first of all.

A commission to enquire into the ownership of fishing apparatus used in Canadian waters to ascertain whether United States capital is not still largely in control of the fishing interests is another recommendation.

The report says there is evidence of a growth of sentiment in favor of the protection of inland fisheries, in the organization of protective associations to help the government in many parts of the province.

Speaking of enforcement of the law as to fish caught out of season, it is stated that efforts are being made to restrict the purchase by dealers of such fish. A number of heavy fines were imposed during the season upon dealers for offenses of this character.

The mandate of the department is that our overseers shall do their duty regardless of persons. All alike must be taught to respect the law by paying the penalties provided for its violation.

"In the discharge of their duty, we desire our overseers to use the iron hand, but with the velvet glove," says the report.

Negotiations With U.S.

The negotiations which have been made with the several states bordering upon the great lakes for the promotion of uniform laws and regulations are, it is stated, believed to have had some effect, since it is understood that United States Secretary Root is seeking to have a joint commission established. Canada cannot expect, however, to have any good results brought about until the United States government had obtained control of its lake fisheries, as negotiations with individual states would be futile. It is maintained, however, that it is not necessary that the power to license and regulate for Canadian waters should be vested in the Dominion government. It is asserted that every possible step for a speedy conference should be taken as the business interests of the great lakes, valued at several millions of dollars annually were at present jeopardized by the lack of a proper policy. The valuable source of food supply is rapidly and steadily diminishing as the proved fishing apparatus is being used, and to meet the situation radical measures, such as artificial propagation, preventing the taking of gravid and immature fish, and rigidly enforcing a close season must be adopted or the lakes will be "depleted beyond restoration."

Fishes, Home Market.

On the important question of the home market, it is stated that licensed fishermen do not appear to be complying with the law which requires them to supply that market. The deputy commissioner, therefore, urges that the department "take such action as will compel the fishermen to recognize the home market as entitled to consideration before a foreign market is supplied, even to the extent of taking steps to prohibit the exportation of fish to the United States."

The home market, properly fostered, should be large enough to handle most, if not all, of the catch. At present higher prices can be obtained outside.

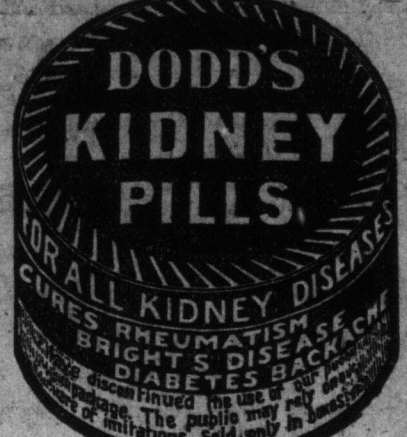
It is asserted that dishonesty and unbusinesslike methods are apparently shown by many fish dealers and buyers. The fishermen claim that they cannot find a home market for their catch, while declaring readiness to supply the market on reasonable notice being received.

Referring to the right exercised by the department to compel fishermen to supply the home market as to payment being made. It is also suggested that the Dominion government be asked to require that the whole catch be supplied to the home market. The report adds:

"There would be no doubt that this could readily be found, and at prices as advantageous as those obtained in the United States. The total catch of this year of whitefish was 2,817,420 pounds. This would relieve the situation of the fishermen considerably and would not prejudice their sales of the coarse fish in the American market. The time will no doubt come when there will be a home market for the whole catch, but that time is not yet; so that total prohibition is for the present out of the question. And the same may be said of government ownership, which has also been suggested as a solution of the problem of home supply and cheaper fish."

Continuing, it is recommended that a commission be created to enquire into the personnel of the fishermen, and the ownership of the gear, tugs, boats, etc., used by them. Comment is made on the discovery, eight years ago, that the fishing industry of the great lakes was largely controlled by a small number of men, the licenses appeared to have been issued in the name of Canadians, and it is added, "It is believed that notwithstanding the fact that the department has since been to issue licenses to British subjects only, such a condition exists at the present time. The fact is so small that, if future licenses were confined to Canadians, it would require all the catch to supply the home market."

It is recommended that before licenses to net in inland lakes are granted, an inspector should make a report, and licenses should not be allowed for lakes containing speckled trout or other game fish, nor when



surrounded by unsettled agricultural lands.

For Re-Stocking.

It is suggested that the Dominion department be asked to consider a system of artificial propagation to check the heavy loss of lake trout spawn.

The depredations of the carp in Lakes Erie and St. Clair are noted, and it is urged that the department do all in its power to encourage the capture of the destructive species.

IN SUPREME COURT.

Ottawa, May 18.—In the supreme court today arguments were heard in the appeal of the Grand Trunk Railway Company v. the City of Toronto and the Canadian Pacific Railway Company. The action was brought by the city to compel the Grand Trunk Railway Company to contribute towards the cost of the construction, reconstruction and maintenance of a bridge on York-street for overhead trestle, claiming that the bridge is a public highway and an agreement between the city and the company as well as at common law. The trial judge, affirmed the court of appeal, held that the liability existed, and that the Grand Trunk Railway Company was not exempt.

NATIVES ATTACK SOLDIERS.

Serious Fight in Cuba in Which One American is Shot.

Washington, May 18.—The navy department has received the first report of a serious fight which occurred at Guantanamo, Cuba, on April 28, between American sailors and natives, in which one American was shot and twenty-two otherwise wounded.

While the sailors were ashore at Guantanamo they left the naval reservation and were attacked by a large band of natives, who used their knives and machetes with telling effect. The blue-jackets had no weapons, and although outnumbered three and four to one, they fought with their fists until all were disabled.

The local police, it is said, instead of attempting to quell the riot, sided with the natives. The sailor who was shot was for a time in a serious condition, but has since recovered.
