Montreal, Jan. 12.—(Special.)—At the annual meeting of the Montreal Telegraph Company, which was held at noon today, the question of the suit of McGraw, et al., against the Great Northwestern Telegraph Company, came up, and in a communication read by the President, Mr. Andrew Allan, the position of the company was stated in the most positive terms.

The communication went on to state that "the complaint of McGraw was in the hands of one or two stock brokers and shown by them around the street, and on the stock exchange, before any service was made upon the company. So far as we know the copy served upon the company may have been served by a broker's clerk. Its contents are utterly rubbish, and clearly got up for the purpose of affecting the price of the stock of the company, against which the action is taken."
