When assured of just dealing, America's workers are able to co-operate in freeing production from the shackles of greed and speculation and influences that manipulate industry to enrich a few who gain unfair advantages, thus preventing production for the ruin of a great body of workers."

"The great struggle of labor in the past has been to assure to workers in their industrial relations the rights of free citizens. Our militant struggle has won general recognition for our demands. But our work is not all militant. We are in a position to contribute to the improvement of production processes and organization."

Judge's Chambers. Before Sutherland, J. Re Canuck Automobiles—G. Russett for applicant. There is no order for company. Application by holder of forty shares in defendant company for winding up order. Judgment: With some little doubt, am inclined to the opinion that the company is not sufficient on which to base an order and the application is therefore dismissed. No costs.

Before Falconbridge, C. J. K. E. Tamblin v. Austin—J. M. Bullen for plaintiff obtained interim injunction restraining defendant till Jan. 7 from building stairs on the wall of the premises leased by the plaintiffs at 1456 Queen Street West, interfering with access to plaintiffs' building.

Before Rose, J. Daugherty v. Annaly—D. L. McCarty, K. C., for plaintiff; A. W. Langmuir for defendant. Appeal by plaintiff from order of local judge of Essex Dec. 22, 1919, refusing to continue an injunction, but making certain provisions for payment of moneys into court, and for order of defendant from order for payment in judgment. The balance of convenience is in favor of the refusal of any interlocutory injunction against building. This, however, does not mean that the defendants are to be allowed to make holes in the walls of the building leased to the plaintiff or to tear out the windows or to make any other structural alteration in the defined premises; against all that there should be an injunction in favor of the plaintiff into which I am granting. The plaintiff ought to go to trial at the next sitting at 11 a.m. Costs in the cause.

Before Sutherland and E. G. McConkey, Canadian Bank of Commerce and F. W. Cowan, Motion for Toronto General Trusts for order setting aside award of arbitrator and remitting matter back for reconsideration. Judgment: I am unable to see that British Westhouse Electric and Mfg. Co. v. Underground Electric Railways is an authority which would make it appropriate for me to hear and determine this application. It may be that this application should be heard and disposed of by a higher tribunal. I must therefore decline to entertain the application with costs.

Before Kelly, J. Hoare v. Moore—R. L. Bracken for plaintiff; E. S. Wigle, K. C., for defendant. Action on contract for purchase of land in Saskatchewan and for purchase by plaintiff of lands in Gosfield north of Regina. In respect of the time and mode of payment, the contract being used upon is defective and incomplete in that it does not contain such particulars as enable the court to enforce performance or apply the equitable remedy of damages. Action dismissed; no costs.

Dietz v. Orckin—J. B. Drake for plaintiff; F. C. Keefe for defendant. Action on contract for purchase by plaintiff from defendant of lands in Windsor for \$4,000; defendant counterclaims for \$400. Judgment: I find that there was not an actual formal tender sufficient in form and that defendant did not accept the form of tender as made or waive his right to strict compliance with the provision for the \$200 reduction on the balance of the purchase money being paid on June 1. The defendant is entitled to the sums claimed in the counterclaim and interest thereon to accordance with the terms of the contract. There will be judgment dismissing the action with costs and on the counterclaim with costs.

Before Sutherland, J. St. Catharines, Jan. 1.—(Special.) J. B.
