Of *George L. King* and *Edwin Wright*, both of the Village of *Bothwell*, County of *Kent*; praying for the passing of an Act authorizing the issuing to them of letters patent, for a "Wrought Iron Driving Pipe," for sinking Petroleum wells from the surface to the rock.

Of the Honorable *Isaac Buchanan*, of the City of *Hamilton*, in the County of *Wentworth*, for himself, and, as Trustee, for the respective heirs of *Peter Buchanan* and *Robert William Harris*, deceased; praying for an extension of the time for the completion of the *Niagara and Detroit Rivers Railway*, and for the protection of the interests represented by him.

Of the *British American Assurance*, the *Provincial Insurance*, and the *Western Assurance Companies of Canada*; praying for an Act of Incorporation, under the name of the "Association of Canadian Lake Underwriters."

Of *William Mosgrove* and others, Members of the Corporation of the City of *Ottawa*, and others; praying that the Bill to incorporate the *Ottawa Waterworks Company* may not become law.

Of *Alexander Wilson*, senior, and others, of the Township of *Onslow*; praying for the passing of an Act to confirm and establish certain lines in the Township of *Onslow*.

Of the *Montreal Board of Trade*; praying that the Bill to extend the Act 23 Vic., Cap. 33, in relation to Fire Insurance Companies not incorporated within the limits of this Province,—to Marine Insurance Companies not incorporated within the limits of this Province, and otherwise to amend the said Act, may not become law.

Of *J. M. Lauder* and others, of the Town of *Brantford*; praying that an Act may be passed to empower *Daniel Brooke*, junr., of the said town, to practice as an Advocate in Her Majesty's County Courts and all Courts of co-ordinate jurisdiction in *Upper Canada*.

Of *Daniel Brooke*, junr., of the Town of *Brantford*; praying for the passing of an Act to empower him to practice as an Advocate in Her Majesty's County Courts, and all Courts of co-ordinate jurisdiction in *Upper Canada*.

Of the Municipality of the Village of *Victoriaville*; praying that the Bill to incorporate the Town of *Victoriaville* may not become law.
