(3) Construction started on July 16, 1949. The last house was completed on November 9, 1953.

(4) This project was financed under section 37, N.H.A. at a borrowing rate of 2 per cent per annum.

(5) The annual rate of depreciation charged against houses and services since completion is 2½ per cent straight line.

(6) It is not possible to provide the information requested in this part because the accounting has been on an over-all branch basis with reference to single houses and not on a project basis. Nor is it possible to recreate the accounting on a project basis because records have been destroyed from time to time in accordance with the policy relating to such matters, as the retention period for the various classes of documents involved has expired.

(7) Total taxes paid to the city of Vancouver from 1950 to 1962—\$1,541,051.38 as determined by city records.
