STATEMENT ON GRANTING OF SEVERANCE PAY

On the orders of the day:

Hon. Jean-Luc Pepin (Minister of Energy, Mines and Resources): Mr. Speaker, I wish to answer two questions on behalf of the Minister of Trade and Commerce (Mr. Winters). The first question, by the hon. member for Fraser Valley, had to do with severance pay at Expo '67.

I am advised by the corporation that provision was made in initial planning, in 1963, for continuity payments to employees who remained with the corporation throughout the time required, in excess of one year, to complete their respective tasks. The purpose of such provision was to avoid disruptions which might have occurred from lack of continuity of employment within the staff of the corporation.

The federal government's share will be 50 per cent of the total amount of payment, which has not as yet been determined.

We have already received indications that some of the governments which did not sign for administrative or other reasons are giving consideration to acceding, and we are hopeful that the membership of the 1967 arrangement will reach or exceed the membership of the current international wheat agreement, which was 49 countries in November of this year.
