POSSIBLE FORMATION OF TRANSATLANTIC COMMON MARKET

On the orders of the day:

Mr. Lloyd R. Crouse (Queens-Lunenburg): I wish to direct a question to the Acting Prime Minister in his capacity as minister of external affairs. In view of the announcement by Mr. Douglas Jay, president of the Board of Trade in the United Kingdom government, that the formation of a transatlantic common market including Britain, Canada and the United States is being studied in both government and private circles, has the minister any comment to make on the position to be adopted by Canada toward a wider area of free trade between Britain and North America?

Hon. Paul Martin (Acting Prime Minister): As is generally known, the Prime Minister has emphasized the importance we on this side of the house attach to the development of a strong Atlantic community. As to any comments I might be invited to make on what Mr. Jay has said, these will have to wait until I have had an opportunity to see what, in fact, Mr. Jay did say.

Mr. Crouse: Will there be a joint meeting of key cabinet ministers of the British and Canadian governments in London in April to study this question of a transatlantic common market?

Mr. Martin (Essex East): I do not want to anticipate the details of the formal announcement, but discussions have been under way for the purpose of establishing with Britain the same modalities that exist between Canada and the United States and Canada and Japan for joint ministerial meetings. and economic matters.
