Russell MacEwan (Central Nova): Mr. Speaker, I ask the Minister of Transport why it is, in view of his statement that he will hear appeals from interveners in the Transair application, that in the matter of Eastern Provincial Airways discontinuing service at Trenton Nova Scotia, he would not consider an appeal by an intervener in that case?

Hon. Donald C. Jamieson (Minister of Transport): Mr. Speaker, it was not a matter of my deciding not to hear the intervener. The hon, member is so persuasive that I would have heard the whole of Nova Scotia. had he asked, but I did not have the legal authority because that case is quite different from the one in question.

THE ARCTIC-UNITED STATES NOTE PRO-TESTING CANADA'S POSITION

Mr. G. W. Baldwin (Peace River): Mr. Speaker, I wished to direct a question to the Secretary of State for External Affairs, but in his absence perhaps the Acting Minister or the Prime Minister might be interested in answering. Has there been received recently a very stiff note from the United States government to Canada protesting against the attempt by the Canadian government to assert jurisdiction for a distance of 100 miles from the mainland and the Arctic islands in the north? Does such a note contain the indication that very stern sanctions will be exercised, economically and otherwise, by the United States in this respect?
