The Armenian community looked to the Government, and I believe supported it because of the promises. It is a simple question; simple justice.

Hon. Pat Carney (Minister for International Trade): The Secretary of State for External Affairs has previously answered that point in the House.

Miss Carney: He also made very clear the point that we value the contribution that has been made by Armenians to Canadian society.
