Mr. Baldwin: I know the Prime Minister has been away for some time and I am sure he will have all kinds of answers ready.

Mr. Speaker: Perhaps I should put the motion, because at this point the question is academic. The point of order can be raised later.

Mr. Baldwin: May I be permitted to advise Your Honour that if the hon, member wishes to speak we intend to pursue the same point of order as the one I raised yesterday; it applies with equal validity to the motion which is about to be put.

PROCEDURE AND ORGANIZATION

MOTION FOR CONCURRENCE IN THIRD REPORT OF STANDING COMMITTEE

Mr. D. Gordon Blair (Grenville-Carleton) moved:

That the third report of the Standing Committee on Procedure and Organization, presented to the house on Friday, June 20, 1969, be concurred in.

Mr. Speaker: I understand the hon. member for Peace River has a point of order.

Mr. Baldwin: Yes, Mr. Speaker. Your Honour will probably recall from the interesting session that we had last night that I had occasion to rise on a point of order in respect of the motion that the President of the Privy Council was struggling to make. That point of order was a very simple one, and though tempted as I am I do not intend to traverse the ground that I then covered. For the purposes of my point of order I hope that the house will take into consideration the fact that the things I said last night apply equally to the motion standing in the name of the hon. member for Grenville-Carleton.

My basic point last night was that this house decided last December that this particular question was then negatived by the proceedings of the house, and consequently cannot be brought forward for discussion now. I raise the same point of order at this time. I ask the house to take into account what I then said and apply them to this context. At the time of the adjournment yesterday the hon. member for Winnipeg North Centre was half way through a very interesting and persuasive argument that I assume he is going to seek permission to resume at this time.

Mr. Speaker: Order. I would be pleased to hear from hon. members, but let me assure them that a lot of arguing will be needed to convince the Chair that the motion of the hon. member for Grenville-Carleton is not properly before the house. There might have been some doubt in connection with the other motion but the situation has now changed. However, I would be prepared to hear argument and make a decision on the point. The hon, member for Peace River submitted an argument yesterday which I listened to with great attention and which I have studied since that time. The hon, member for Winnipeg North Centre has participated in the debate, and if he feels that he should complete the argument that he was making last night I will of course be pleased to hear him
