## DOCTOR CONVICTED

Former Drumbro 'Sam' Convicted  
at Detroit of Manslaughter.

Detroit, Oct. 10.—Dr. George A. Fritch charged with manslaughter, following the death in his private hospital here 18 months ago of Mrs. Victoria Kalenda, was found guilty by a jury late to-day. It was charged that Fritch performed an illegal operation on Mrs. Kalenda.

The physician was given his liberty on \$5,000 bond to await sentence. He declares he will appeal to the Supreme Court for a new trial.

Three other cases against Dr. Fritch now pending, will be at once pushed through, according to the prosecuting attorney.

Fritch, who is a native of Drumbro one... has been arrested before for performing illegal operations.

He has always managed to escape conviction, however except in the case of Mabelle Millman a young city student. For this he was sentenced to an indeterminate term of seven to 15 years, but was pardoned after serving three years in Jackson state prison.

### Strike Gas in Kent.

At a depth of 235 feet a gas well was struck on Bagnall's farm yesterday and is now giving out gas at a rate of one million feet per day.

That the wheels of industry will soon be turning in the Warton casket factory is almost a certainty. Mr. C. Hill, who has been manager of the chair factory, approached the Council making an offer for the plant. Mr. Hill stated that the backing of several Windsor men, who were willing to subscribe \$40,000, which sum is necessary to make the plant a going concern as a furniture factory, had been secured.

According to assessment returns Preston now has a population of 5,284, an increase over last year of 318. St. Mary's will vote on a by-law on November 10th to spend \$11,000 on a soldiers' club house and a monument.

Mrs. D. Gardiner, Tilbury, is suffering from burn and shock received when lightning struck her house on Sunday.

London teachers are asking for an increase of \$300 in 1920 and an additional increase of \$200 in 1921. Fire of unknown origin damaged one of the buildings of the Canadian General Electric at Peterborough.

Above is an exact reproduction of the Referendum ballot, showing the correct way to Vote in order to sustain the Ontario Temperance Act as it stands.

The beer of the ballot is 118% stronger than the Ontario Temperance Act now allows, and over five times as strong as the limit allowed for beer defined as non-intoxicating in Great Britain and the United States.

### Must Answer Each Question

1. Unless you vote on every question your ballot is spoiled.
2. You must mark your answer to each question with an "X" only. Anything else would spoil your ballot.
3. Unless a majority vote "No" on question 1 the bars will be restored and the sale of all kinds of intoxicants permitted.
4. Unless a majority vote "No" on questions 2, 3 and 4 the Ontario Temperance Act will become almost worthless.
5. The only SAFE course is to mark your ballot as shown above.
