

## An Act to incorporate the "Mount Hope Institute" at London.

**W**HEREAS an Association hath existed for some years at London under the name of "The Mount Hope Institute," founded by the Ladies of the Sacred Heart, and designed for the Education of Females, and for affording an Asylum for destitute Orphans; And whereas the said Ladies have, by their Petition, prayed that the said Association may be incorporated, and in consideration of the great benefits which must arise from the said Institution, it is expedient to grant their prayer: Therefore, Her Majesty, &c., enacts as follows:

Preamble.

1. Margaret Mary Gillaby, Sarah Limoges, Anna Hanratty, Mary Josephine Begly, and such other persons as are now or shall under the provisions of this Act, become Members of the Institution, shall be and are hereby declared to be a Body Politic and Corporate in name and deed, by the name of "The Mount Hope Institute," and by that name &c., shall have perpetual succession and a Common Seal, and shall have power from time to time to alter, renew, or change such Common Seal at their pleasure, and shall by the same name, from time to time, and at all times hereafter, be able and capable to purchase, acquire, hold, possess and enjoy, and to have, take, and receive for them and their successors, to and for the uses and purposes of the said Corporation, any lands, tenements and hereditaments, and real or immoveable property and estate, situate, lying and being within this Province, not exceeding in yearly value the sum of two thousand pounds currency; and the same to sell, mortgage, alienate, and dispose of, and to purchase others in their stead for the same purpose; and by the said name shall and may be able and capable in law to sue and be sued, implead and be impleaded, in as large, ample, and beneficial a manner as any other Body Politic or Corporate, or as any persons able or capable in law may or can sue and be sued, implead and be impleaded, answer and be answered unto, in any matter whatsoever; and any majority of the Members of the Corporation for the time being, shall have power and authority to make and establish such rules, orders and regulations, not being contrary to this Act, nor to the laws in force in this Province, as shall be deemed useful or necessary for the interests of the said Corporation, and for the management thereof, and for the admission of Members into the said Corporation, and from time to time to alter, repeal, and change the said rules, orders and regulations, or any of them, or those of the said Institution in force at the time of the passing of this Act; and shall and may do, execute, and perform all and singular other the matters and things relating to the said Corporation and the management thereof, or which shall or may appertain thereto, subject nevertheless to the rules, regulations, stipulations and provisions hereinafter prescribed and established
