MAKING STRONG FIGHT

George E. Daniel Under Arrest in Seattle and Wanted in Dawson He Has Been Twice Released But Only to Be Re-Arrested—Break in Wire Causes Delay in Matter.

Seattle, Nov. 14, via Skagway, Nov. 15.—George E. Daniel who is arrested here as a fugitive from the crime of embezzlement having been committed by Dawson, where it is alleged he was with \$30,000 belonging to Barstch, who is Dawson agent of the Dawson Bros. of this city, is making a hard fight to prevent extradition to Canada. He has been twice released from jail but each time he has been re-arrested, the last time on a warrant signed by the British vice consul. The break in the telegraph line is offered as the reason for delay in securing papers from the Yukon.

ARE FIRST TAXPAYERS

Murray & Ross Have Distinction of Making First Payment.

To Messrs. Murray & Ross, wholesale liquor dealers, belong the distinction of being the first ones to pay their taxes for the year 1901. Promptly at 9 o'clock yesterday morning a representative of the firm presented himself at Collector Smith's desk with his little blue slip, receiving in exchange for \$825, less the five per cent. discount, a receipt showing his rates for the present year to have been paid. Outside of the big corporations, the firm is one of the heaviest tax payers in the city.

During the day about \$2000 was received, it being considered quite a good starter for the first day. There yet remain only ten days in which to take advantage of the five per cent. discount, such allowance not being granted after November 30. Next week it is thought will see the heaviest receipts of the year, as all of the large companies and heavy rate payers will scarcely fail to take advantage of the rebate. The aggregate taxes payable by the Northern Commercial Co. amounts to \$27,000, and by paying them before December 1 a saving of \$1250 will be effected.

A local contemporary in its issue this morning made the statement that the four per cent. penalty attaches after December 1, which is not true. During the month of December taxes are received at par, the penalty not being added until after December 31. The general opinion is that there will be comparatively few delinquencies and the tax sales will be confined generally to side hill lots well up toward the summit of the ridge where it would be a very hard matter to build a residence without the use of ropes to tie the house down.

GALLANTLY RESCUED

Registry Clerk Bitts Slightly Injured Slipping a Runaway.

In the sleigh were a lady and gentleman who just before Mr. Bitts attempted a rescue were violently thrown to the ground. As the horse came by he grabbed for and secured the bridle rein, but was knocked from his feet and dragged considerable distance, pluckily holding on to the reins and finally bringing the animal to a stop. DOG DAYS ARE HERE

First Canine Case of Season Heard This Morning.

The police were notified and Forrest, who is a boy 16 years of age and the size of a 12-year old, was taken into custody and brought before Judge Macaulay this morning. The little lad claimed to have found the dog astray and to have advertised him in the Sun, but as he said, "Nobody seemed to have read the advertisement," so he sold the dog. It developed that the dog was sold two days before the advertisement appeared. Finally the little fellow weakened and began to cry. He said he had done very wrong and begged of his honor to not send him to jail on his mother's account. He said he would refund the \$15 as soon as he could earn that amount. The judge talked like a father to the boy who made all sorts of promises of future upright living and to the lad's credit it can be said that he meant what he said—at the time at least. He was sentenced to 30 days at hard labor but the sentence was suspended pending his future deportment.

The boy left the courtroom feeling that he will be careful in his future canine traffic. Young Forrest is a bright little fellow whose face is not that of a bad or dishonest boy and his excuse for selling the dog was that a man had told him to do it.


