SUPREME COURT CASE

Judgments Delivered in a Number of Important Cases Yesterday

OTTAWA, June 10.—The Supreme Court this morning to deliver judgments. The first case taken up was that of Higgins v. Walker.

This was a suit arising out of an article which appeared in the "Colonist" newspaper, Victoria, B.C., instating that Mr. Walker (now Judge Walker and then Attorney-General for the Province) had an interest in the construction of the graving dock contract, which was carried on as a private work.

In the court below the plaintiff was awarded \$2000 damages and costs, on which judgment defendants appealed to the Supreme Court.

To-day judgment was given in a new trial without costs, unless the plaintiff (Judge Walker) accepts before 10 o'clock to-day to pay the costs of the trial.
