The Sick and Funeral Benefits.

The Sick and Funeral Benefits are as follows: The benefits are as follows:—(1) During each calendar month sickness benefit of \$2.00 a week for the first two weeks, \$3.00 a week for the next two weeks, and for the remainder of the calendar month a further sum of \$5.00 a week for the next three weeks. All in all a total of \$20.00 for the month. (2) For funeral expenses \$100.00.
