On motion of Mr. Bennett, it was resolved,—That when this House adjourns on Monday, October 31, 1932, it stands adjourned until Wednesday, November 2, 1932, and that on the said Wednesday, and subsequent Wednesdays until the long adjournment of the present session, the sittings shall in every respect be under the same rules as provided for other days.

By Mr. Seguin, for Mr. Pouliot:—Order of the House for a copy of the Formula K-9 of the National Revenue Department.

By Mr. Jacobs, for Mr. Casgrain:—Order of the House for a copy of all correspondence, letters, telegrams, petitions and other documents, in connection with the ferry boat service between Ile-aux-Coudres and Les Eboulements, in the county of Charlevoix, since the 1st of January, 1932, together with the evidence taken in writing of all the witnesses heard at the hearing held by Mr. F. E.
