business and, though it is one-tenth of the number of banks, it does 1.8 per cent of the business.

Mr. DIEFENBAKER: How many false coupons were found, approximately?

Mr. ST. LAURENT: In connection with this incident, it is not a matter of false coupons; it is a matter of the coupon accounts being overdrawn by the orders made for coupons. That was not a case of forged coupons being used; it was a case of the coupon accounts in certain branches being cverdrawn.

Mr. DIEFENBAKER: To what extent, approximately?

Mr. ST. LAURENT: I do not remember exactly what it is, but I will let the hon. member see the full reports I have on the investigation, and he will realize what can be stated publicly about it at the present time without embarrassing the continuation of the investigation. Black market operations have to be checked constantly and those investigations are being continued to ascertain what outsiders were involved. When the hon. member sees the reports he will realize how far we should go in giving out details of what has been uncovered up to the present
