MR. W. C. THOMSON

Mr. Hees:

1. What was the total amount of money paid to W. C. Thomson by the Department of Veterans Affairs from January 1, 1945, to date, for (a) services; (b) expenses; (c) disbursements?

2. Of the above payment, how much was paid for abstracts of title, loan application, or other transactions involving assistance to veterans (a) handled by Mr. Thomson; (b) distributed to agents by Mr. Thomson?

Mr. Muich:

1. (a) \$252,760.70; (b) \$134.48; (c) \$92,722.15.

Note: The above sums include payments between April 1, 1944, and January 1, 1945, it being impossible to separate the payments in this particular period from those for the whole financial year 1944-45 as the vouchers for the year are not available. For the same reason, it is not possible to distinguish between disbursements and expenses for this period but the amounts in question are a small part of the whole.

- 2. The following are payments for transactions involving assistance to veterans for \$248,340.70 of the figure of \$252,760.70 shown in answer to No. 1 (a):
- (a) Litigations and commissions—handled by Mr. Thomson: No. of cases, 6; amount, \$4,437.90. Legal services relating to titles *re* land purchased for veterans—handled by Mr. Thomson: No. of cases, 7,848; amount, \$215,517.80.
- (b) Legal services relating to titles *re* land purchased for veterans—distributed to agents by Mr. Thomson: No. of cases, 1,622; amount, \$28,385.00.

Note: Due to the vouchers for the fiscal year 1944-45 not being available, the balance of \$4,420.00 cannot be broken down as between the cases handled by Mr. Thomson and those distributed to agents.

- 2. An armoury is at present under construction at Newcastle. In addition national defence wartime buildings were converted to provide reserve force accommodation at Chatham, Moncton, Saint John and Sussex.
 - 3. Construction authorized:

Navy. (a) Renous—expansion of Royal Canadian Naval magazine.

Army. (b) McGivney—thirty-six permanent married quarters.

Air. (c) Chatham—aerodrome development and construction of building and facilities. (d) Moncton—construction of buildings and facilities.
