## UNPLACED WORK APPLICANTS, NEW BRUNSWICK

### Question No. 148-Mr. Robichaud:

1. What is the number of unplaced applicants for each employment service office in New Brunswick, for the most recent date for which such data is available?

2. What is the comparative figure for similar date in 1957 and 1958?

# Answer by: Hon. Michael Starr (Minister of Labour):

Unplaced applicants registered at offices of the unemployment insurance commission's national employment service in the province of New Brunswick at February 5, 1959, the latest date for which data are available, and for the corresponding dates in 1958 and 1957, are as follows.

#### Questions

It should be pointed out in connection with these figures that in 1959 certain fishery benefit claimants are excluded from the count of unplaced applicants. Such claimants were included in the 1958 counts. In order to render the 1958 figures comparable with those of 1959 (and also with those of 1957 when fishermen were not under unemployment insurance coverage) the number of fishing benefit claimants at February 6, 1958 for each local office has been estimated, and the 1958 figures reduced by these amounts.
