SPEECH FROM THE THRONE

CONTINUATION OF DEBATE ON ADDRESS IN REPLY

The house resumed, from Thursday, January 25, consideration of the motion of Mr. Rodrigue Bourdages for an address to His Excellency the Governor General in reply to his speech at the opening of the session.

Mr. J. A. McGrath (St. John's East): May I join, Mr. Speaker, with those who have preceded me in this debate in offering congratulations to the mover and seconder of the motion for an address in reply to His Excellency's speech. Both these hon. members acquitted themselves in a most capable manner.

During the course of the remarks of my friend the hon. member for Burin-Burgeo (Mr. Carter), who spoke earlier in this debate, I could not help noticing his reference to the speech from the throne—and I paraphrase the hon. gentleman's remarks—as a Christmas stocking bulging with goodies. My hon. friend is not far from the truth. We have already seen some of the goodies in that Christmas stocking. To the 3,000 surviving members of the Newfoundland overseas forestry unit I will wager that it is the best Christmas gift they have received in a long time. To the two thirds of the population of Newfoundland resident in the Avalon peninsula of my province-I refer to the easternmost part-it has certainly been a memorable Christmas gift. For the first time they have now seen tangible results of efforts on the part of this government to provide the important easternmost part of Newfoundland with communications and transportation to the mainland of Canada. I refer, of course, to the announcement in the speech from the throne that parliament will be asked to authorize the institution of an automobile ferry service
