#### [Translation]

Mr. Pelletier: Mr. Speaker, I am not aware that any announcement was made along this line. However, I know that a committee has been formed in which six federal departments are represented at the civil servants level in order to study the question of gallantry awards.

I want to point out at the same time that some press reports these last few days were somewhat absurd. Indeed, they were dealing with awards granted only in war time, which is irrelevant at present since Canada is not at war with anybody.
