

Regional Economic Expansion. REQUEST FOR STATEMENT ON ALLEGATIONS BY QUEBEC FEDERATION OF LABOUR CONCERNING USE OF DEPARTMENTAL FUNDS

**Mr. John Burton (Regina East):** Mr. Speaker, my question is supplementary to the one asked by the hon. member for Winnipeg North Centre. In view of the revelations made by the Quebec Federation of Labour that the industrial development strategy of the department channels public funds away from the most depressed areas, among a number of other charges, would the Minister of Regional Economic Expansion be willing to make a statement on motions at the earliest possible date dealing with the various points that have been raised?

### GOVERNMENT ORDERS

#### INCOME TAX ACT

The House resumed, from Friday, December 10, consideration of the motion of Mr. Benson for the third reading of Bill C-259, to amend the Income Tax Act and to make certain provisions and alterations in the statute law related to or consequential upon the amendments to that act, and the amendment of Mr. Lambert (Edmonton West) (p. 10363) and the amendment to the amendment of Mr. Burton (p. 10370).

**Hon. Robert L. Stanfield (Leader of the Opposition):** Mr. Speaker, I was sorry not to be in the House on Friday when the Minister of Finance (Mr. Benson) spoke on the third reading of the tax bill.

**Mr. Mahoney:** Where were you?

**Mr. Ricard:** None of your business.

**Mr. Stanfield:** I am happy to see hon. members opposite taking a great interest in my whereabouts; that is very encouraging. I understand that I missed an interesting performance in this House. At least one commentator, whose report I read over the weekend, accused the Minister of Finance of indulging in a certain amount of bullying. With all due respect, I would disagree with that commentator having now read the minister's speech. The minister may have felt that he was being tough and ruthless but, after all, if you are going to be that you must have something more going for you than just a parliamentary majority. You have to have some arguments as well; you must have at least a little logic on your side. If you do not have that on your side, then all the bluster in the world will not help you very much.

This is why, being as charitable as I can, I would describe the minister's performance really as an exercise in desperation. He spent, of course, very little time praising the bill, and I do not criticize him for that.
