Hon. Jack Cullen (Minister of Manpower and Immigration): 1. Kamloops, Nanaimo, Lac La Biche, the entire province of Saskatchewan, northwestern Ontario, Hamilton-Wentworth, Lac St. Jean, Drummondville, Kedgwick-St. Quentin, West Prince, East Kings, Guysborough, Halifax (north-end/Spryfield-Kline Heights) Port au Port, Labrador Straits, Yellowknife-Rae Edzo.

- 2. The number of people placed in the existing labour market or in training as a result of CES activity is in excess of 2.000.
- 3. CES activity is ongoing in the above mentioned communities.
- 4. No costing for individual projects was agreed upon by the provincial and federal ministers involved. However, CES at a

federal level has spent \$6.4 million, which includes all operating costs in the regions and in Ottawa, as well as funding of the communities involved in the CES process.
