(a) 313 applications were received; (b) 259 were eligible; 86 were approved; (c) 27.0 per cent of the estimated eligible costs; (d) 95 were received; 14 were approved; (e) 16.3 per cent; (f) (i) 7.3 per cent (23 applications), (ii) 43.1 per cent (135 applications), (iii) 5.1 per cent (16 applications); (g) Agricultural industries, service industries incidental to agriculture, logging, mining, quarrying and oil wells, quarry and sand pits, service industries incidental to mineral extraction, trade contracting, other products industries, wholesale, business service industries, local government service, education service industries, accommodation service industries, membership organization industries.
