MEDICAL CARE

ONTARIO HOSPITAL INSURANCE PLAN—DOCTOR' THREAT TO BILL PATIENTS DIRECTLY

Mr. Jean-Robert Gauthier (Ottawa—Vanier): Mr. Speaker, my question is for the Minister of National Health and Welfare. It concerns the directive to all hospitals and doctors not to accept OHIP health cards but rather to bill the patients directly. Would the Minister use his influence and give the leadership that we expect of him, and tell all Canadian doctors that to use the health care system of Canada as a political arm or a political tool is both unethical and immoral?

Hon. Jake Epp (Minister of National Health and Welfare): Mr. Speaker, I believe I have already indicated that I do not see the use of an OHIP card or any other card from a resident of another province as being an action whereby a patient, a person who needs medical assistance, should be put at risk. That is the public health care system that we have which has been endorsed by all Parties in this House and endorsed by the provinces of Canada. I have said very clearly—and that is why I had it checked to make sure—that the portability requirements of the Canada Health Act were being observed. They are being observed, from all the knowledge that I have and that I have received.

There is obviously a position that I take as Minister of Health. I expect Canadians to receive the medical care to which they are entitled whether they are inside their province or outside their province.
