It is to allow Canadian electors who are out of the country for an extended period of time, such as government employees or employees who are working for large companies, to take part in elections. They continue to be Canadian taxpayers and many of them want to take part in elections. At the present time, there is no system for them to vote.

This arose out of a letter from a constituent who was in Europe during the last federal election who wanted to vote but could not. He was ineligible for a proxy vote. The purpose of this bill is to remedy that situation.

The Acting Speaker (Mr. DeBlois): Mr. Wilbee moves that the bill be now read the first time and printed.
