SUPREME COURT

ADJOURNS TILL 22ND

St. John Case Among Those on the Docket—Judgments Also on Sept. 22

Fredericton, N. B., Sept. 12.—The September sittings of the supreme court opened this morning, the full bench present.

No common motions were presented to the session occupied only a few minutes.

The chief justice announced that for various reasons presented by the counsel engaged in the cases entered on the docket that no cases would be argued this term, but all would be taken up at the November sitting. He adjourned the court until September 22, when any common motions then ready would be heard and judgment be delivered, after which the court would adjourn sine die.

SITUATION IN CHINA SERIOUS

Cheong, Western China, Sept. 12.—A serious rebellion has occurred in the district of Cheong. The soldiers refuse to obey instructions, and are trying to bring force against the government control of the railway. The schools are closed. Business has been suspended and unless the uprising is stopped it may lead to general rebellion. Conditions are precarious. The missionaries are concentrating here. Four foreign gunboats provide all protection. Cheong is quiet. The uprising is not at present directed against foreigners.

This is the first direct cable despatch from Cheong, China, since the recent alarming reports.

The members of the St. John Presbyterian met this morning in the school room of St. Andrew's Presbyterian church, Germain street, to deal with business in connection with the welfare of the church. One of the matters before the session was the question of the pastor of St. Matthew's church, Douglas avenue, speaking at political meetings.

The meeting opened with prayer offered by the moderator, Rev. Dr. W. H. Smith, of Fredericton. Reports on several matters were submitted. The first was from L. B. Gibson, of St. Stephen. He spoke of the work of the Presbyterian church in the Milltown section, presented by Rev. J. H. Anderson, who had been in the city, was bravely upholding the list, and giving more per capita than any other church in the synod. There was no possibility, he said, of a union between Scotch Ridge church and Milltown.

Rev. J. H. Anderson submitted a report bearing on matters in connection with the financial condition of the church. The committee related, he said, the delicacy of the situation, and they felt that the peace and harmony of the church were endangered because of certain events which had transpired and to which much publicity had been given. The committee should not be reduced because of the present financial standing, but the future financial condition of the church, His Honor Judge Forbes said he agreed with the greater portion of the report except in the matter of the pastor. He did not know whether a grant should or should not be made. On account of the conduct of the pastor the situation was delicate. Since there was no communication with the church, and the matter was not before the presbytery, correctly speaking, it was difficult to deal with.

Rev. H. R. Reid said that the financial standing of the congregation must be considered. The committee thought that the matter might be cleared by some action of the presbytery before very long. At present the congregation had not dealt officially with anything bearing on the pastor's stand. There was no enmity between the trustees and the pastor, although it might have appeared so from what had been published in a letter in the press recently. Those whose names were signed to the letter, he said, were at a loss to understand the meaning of the letter, and he was sure that all who had signed it had been pledged to keep its contents secret.
