RELEASE OF INFORMATION ON COMBINES INVESTIGATIONS

Question No. 2,380-Mrs. MacInnis:

- 1. What is the reason that no information is released about investigations being undertaken by the Director of Combines Investigation?
- 2. What is the amount spent on investigation in each of the last ten cases referred to the Director?
- 3. How many witnesses other than employees or officers of the company under investigation were called or interviewed in each case?

Hon. Ron Basford (Minister of Consumer and Corporate Affairs): 1. The reasons, as explained in detail by the then Minister of Justice, will be found in Unrevised Hansard for November 23, 1964, at pages 10377-78.

2 and 3. Investigations are instituted by the Director of Investigation and Research whenever he has reason to believe there has been a violation of the Combines Investigation Act. The Director's reason to believe may result from information or complaints brought to his attention in a variety of ways. Statistics are not kept in a manner which permits a clear identification of "the last ten cases referred to the Director". Assuming this to mean the last ten instances in which formal inquiries have been instituted, the information is as follows:
