

**ELECTIONS, CONTROVERTED—Continued:**

J. G. Vansittart, Esquire, (Returning Officer) to appear at the Bar, and answer for his Return, 11. (*Vide House*, 9.) Petition of E. Deedes and others, of Oxford, expressing their firm conviction that Mr. Vansittart was influenced by no improper motives in making the Return, 66. Petition of E. Deedes, Esquire, making known a circumstance which he conceives sufficient to prove the honorable motives by which Mr. Vansittart was actuated, 68. *Vide infra*, 10.

10. Petition of Peter Carroll, Esquire, against the Honorable Francis Hincks, 30. Recognizance, 37. Resolution that Mr. Hincks (who since the election had accepted office) be permitted to defend against the petition; Day appointed for consideration of petition, 38. Order rescinded, and another day appointed, *ib.* Lists of Witnesses; Ballot, and Committee, 49. Report that Mr. Hincks was duly elected, and ought to have been returned, 63.

Clerk of Crown in Chancery ordered to attend forthwith, with the Return and Poll-books; He attends accordingly, and presents the same, 3. Petition of Antoine Polette, Esquire, (one of the candidates) complaining of the Election, and praying that he may be declared duly elected; 7. Motion, that in obedience to a Writ of Election, an Election for Three Rivers was held on the 29th December; Superseded by Previous Question, 15. Recognizance, 23. Petition of Pierre Benjamin Dumoulin, Esquire, (a candidate) against the election, 32. Petition of Pierre Vezina and others, Electors, in favor of Mr. Polette, 36. Petition of Mr. Dumoulin withdrawn, 49. Petitions of Mr. Polette and of P. Vezina and others, withdrawn, 50.

17. *Waterloo* (County):—Petition of Adam Johnston Fergusson and others, against James Webster, Esquire, and in favor of Mr. Fergusson, 29. Recognizance, 57. Day appointed for consideration of petition, 68. (24th March; *Parliament prorogued on the 23rd.*)

2. Bill to make better provision respecting Emigrants, and to defray the expense of supporting Indigent Emigrants; Presented; Read second time; Committed; Considered, and amended; To be engrossed, 9. Recommended; Considered, and further amended; Passed, 14. By the Council, 15. Royal Assent, 80. (11 Vic., c. 1.)
