P. Taché*, and the Honorable Messieurs *Aikins*, *Alexander*, *Armand*, *Blake*, *Burnham*, *E. H. J. Duchesnay*, *Letellier de St. Just*, *Olivier*, *Sanborn*, *Simpson*, and the Mover.

The question of concurrence being put thereon, the same was resolved in the affirmative, and

*Ordered* accordingly.

On motion of the Honorable Mr. *Campbell*, seconded by the Honorable Sir *E. P. Taché*, it was

The Order of the Day being read for the second reading of the Bill intituled: “An  
“ Act to amend Chapter Sixty-two of the Consolidated Statutes of Canada, and to provide  
“ for the better regulation of Fishing and protection of Fisheries,”

On motion of the Honorable Mr. *Campbell*, seconded by the Honorable Sir *E. P. Taché*, it was

*Ordered*, That the same be postponed until Monday next.

The Order of the Day being read for the second reading of the Bill intituled: “An  
“ Act relative to Summary Convictions,”

On motion of the Honorable Mr. *Currie*, seconded by the Honorable Mr. *Christie*, it was

*Ordered*, That the same be postponed until Monday next.

Pursuant to the Order of the Day, the House resumed the adjourned Debate on the motion of the Honorable Sir *E. P. Taché* for an Address to Her Majesty, praying that She may be graciously pleased to cause a measure to be submitted to the Imperial Parliament for the purpose of uniting the Colonies of *Canada*, *Nova Scotia*, *New Brunswick*, *Newfoundland* and *Prince Edward Island*, in one Government, with provisions based on the Resolutions which were adopted at a Conference of Delegates from the said Colonies, held at the City of *Quebec*, on the 10th of October, 1864.

*Ordered*, That further Debate on the said motion be postponed until to-morrow.
