THE TURF.

RATES FOR USING HAMILTON'S TRACK.
The directors of the Hamilton Jockey Club have decided upon the following rates to be charged for horses trained on their track:—Membership in the association will cost \$5, as in 1893, and this fee entitles the member to train one horse free of charge on the race track, but if stable room is desired, an extra rate of \$1 per month for each horse is to be charged. Trainers are required to pay \$5, which entitles them to the privilege of using the track for the season, and in addition to this are required to pay \$1 for each horse trained on the track, whether stabled there or not. These rates are identical with those charged by the Windsor Association.

LOCAL NOTICES.

In the bicycle road race to St. John's and return last evening, Clay Manville, the Forest City champion, made a remarkably good showing. Mounted on a 22-pound "Quadrant" he covered the distance of a little over ten miles in a trifle over 33 minutes, and this in spite of the fact that he had only been in training four days. The limit man, J. F. Moyle, with 15 minutes' start, proved an easy winner, as he had been expected to be. The allowance was altogether too much in a ten mile race. Manville will make an effort in a few days' time to beat his performance of last evening and with a little more training it is safe to say all existing local records will go. Messrs. Carroll, McKenzie & Co. (by whom Manville is employed), state that the little featherweight "Quadrant" road racer stood the rough roads wonderfully, returning in excellent condition and as rigid as a rock.

The City Council Discusses Estimates.

STREETS SUFFERED MOSTLY.

Salaries Talked About a Good Deal, but Remain Unchanged.

FREE LIBRARY DEBENTURES.

The issue of \$20,000 of Debentures Decided Upon—Band Concerts May, but no New Band Stand—What the Parking Was Done.

The City Council met last night and considered the estimates of the year. Mayor Essery was absent in Detroit, and Ald. Shaw was moved into the chair. The members present were:—Ald. Shaw, Parnell, Judd, Dreaney, Garratt, Carrothers, T. Jones, J. W. Jones, O'Meara, J. Heenan, Pritchard, Taylor, J. Fitzgerald, Scarrow, P. J. Fitzgerald, Nutkins, Ald. O'Meara moved an adjournment to take up the estimates at a regular meeting. The scant meeting to consider so important business was his reason; also because at a special meeting of the Council no vote of motion could be given.

Ald. Judd pointed out that it was absolutely necessary that the rate for the year should be struck before the first of May in order to permit the City Clerk to extend the rolls in time.

Ald. O'Meara's motion was not seconded, and the Council then went into committee of the whole.

Ald. Judd read the report of the Finance Committee.

Printed copies of the estimates were laid before the Council.

Ald. O'Meara moved that the rate be struck at 18 1/2 mills, and that the matter of reducing the expenditures be referred to No. 1 Committee with power.

Ald. Parnell seconded the motion.

Ald. Taylor objected to what he said was a special attack on No. 2 Committee. He strongly criticised the idea of cutting off one-half of the salary of the Medical Health Officer.

Ald. Judd said that there was an item of \$5,000 in the estimates as coming from the London & South-eastern. In view of the M. C. R. difficulty that item was at present a doubtful one.

Ald. Taylor said he thought in case the M. C. R. pulled out, that the new Lessees would take over the L. & S. E. and pay the rental of \$3,000.

Ald. Judd was not sure on the point. In answer to Ald. T. Jones, he said it was true that something would probably come from the lease of the Port Stanley over expenditures for repairs to the road.

Ald. O'Meara objected to band concerts being cut off, and proposed a cut in official salaries to make up therefor.

Ald. Judd's motion passed.

Receipts, section No. 1, other than taxation, \$92,404, 1/2. Section No. 2, taxation, was laid over.

Uncontrollable expenditure, amounting to about \$175,000, was also passed.

Controllable expenditure was then taken up. On the item of \$3,000 for law expenses, Ald. Judd said that law expenses, he did not wish to explain, would probably come up this year. The \$1,800 for election expenses included the \$700 necessary for taking a vote upon water-works insurance.

No. 1 Committee recommended that the \$500 for Police Benefit Fund be struck out.

Ald. Garratt moved that the amount be not struck out.

The Chief of Police said that the fund was greatly taxed by payment to two members of the force killed while on duty of over \$2,500. A little over a thousand dollars was at present in the treasury.

Ald. Garratt's motion carried.

Incidental expenses last year amounted to \$5,854.62; this year the amount was placed at \$2,586.09.

The amount was criticised, and a motion by Ald. Carrothers to reduce the sum to \$2,000 was carried.

When salaries came up, Ald. Parnell moved a reduction of \$200 each to the salaries of the City Clerk, City Treasurer and City Engineer. The motion was voted down, Ald. O'Meara, J. W. Jones and the mover only supporting it.

Ald. O'Meara moved that the services of the Assistant Engineer be dispensed with.

Ald. J. W. Jones seconded. He claimed that there was absolutely no use for the assistant in the Engineer's office. A boy for \$300 a year could do the work.

Ald. Pritchard moved that the Assistant Engineer's services be dispensed with after October 1, and that one-fourth of the item of \$780 for salary be struck out.

The item was not struck out.

The item of clerk to Assessment Commissioner of \$150 was cut off.

Ald. Garratt moved an addition of \$100 to the salary of Secretary James Bell, at present \$500. Mr. Bell was highly commended as an efficient officer. The motion carried on the casting vote of Ald. Shaw.

The usual grant of \$500 to the Band for music in the Park was moved by Ald. Garratt and agreed to by 7 to 6.

At this juncture a telegram was read from Ald. Coo, protesting against the holding of the meeting to strike the rate. The City Clerk said the notice had been sent.

A deputation comprising Drs. Renwick, Weld, Gardiner, Niven and Drake was present in connection with the proposal of the Board of Health to reduce the salary of the Medical Health Officer from \$1,000 to \$500.

Dr. Gardiner addressed the Council, and pointed out the several duties of the official. Incidentally, he said that it was quite likely that this city would have one or two cases of small-pox this year. The salary was very small at present for the duties the Medical Health Officer was expected to perform.

Dr. Niven and Dr. Weld spoke along the same line.

Ald. J. W. Jones moved the adoption of the proposal to reduce.

Ald. Taylor moved that the salary remain as it was.

Ald. J. W. Jones said if the office was vacant to-morrow at \$500 twenty applicants would be after the position.

Ald. Pritchard moved that the salary be \$500.

A communication was read from Medical Health Officer Hutchinson, having reference to the extent of his duties, which occupied his full time. The death rate had been reduced in nine years from 22 to 13. If the salary was reduced, the Board would have to relieve him of some of his duties.

Ald. Scarrow said the Board intended to do this.

The salary was allowed to remain as before.


No. 2 Committee's estimates were taken up. No. 1 Committee recommended a reduction of \$150.
