It is further agreed that the produce and manufactures of His Britann Majesty's territories are entitled to any advantages in respect of modifications Dispositions IV and V annexed to the Spanish customs tariff which may

accorded in future by Spain to any foreign country.

Notwithstanding the provisions of the preceding paragraphs, His Britanding Majesty will not be entitled to claim for raw materials or manufactured article the produce of the territories of His Britannic Majesty the benefit of any special treatment which His Catholic Majesty has conceded or may concede to products of Portugal or to those originating in and proceeding from the Spanish zone of Morocco.

ARTICLE 6

Articles the produce or manufacture of Spain imported into His Britannia Majesty's territories, from whatever place arriving, shall not be subjected of the subjecte other or higher duties or charges than those paid on the like articles, the production manufacture of any other f or manufacture of any other foreign country.
