EDUCATION

EQUALIZING OF OPPORTUNITY—FINANCIAL ASSISTANCE TO PROVINCES

Mr. F. S. ZAPLITNY (Dauphin) moved: That, in the opinion of this house, the government should take into consideration ways and means of equalizing educational opportunity across this dominion and granting financial assistance to the various provinces for this purpose.

He said: Mr. Speaker, in rising to move this resolution I am doing something with which I am sure a great many members of this house agree. Since this resolution first appeared on the order paper some time ago, a large number of hon. members as well as others outside the house have expressed interest in it. I hope therefore that what I have to say and what other hon. members may have to say on the resolution will be carefully considered by the government with a view to doing something about it when the debate is ended.

I should like to present a few reasons why I consider the matter of education and the question of federal aid to education to be among the most vital issues before us to-day.

Education is practically synonymous with civilization. If we read history we realize that in some ways education must be considered older than civilization itself, because had it not been for education, whether in an organized or in an incidental form, no civilization would have been possible.

I ask the house to give consideration to the fact that education is in the modern world one of the chief sources of power. We talk about natural sources of power, about solar and
