RECOVERY OF INCOME TAX FROM EMPLOYEES STATIONED IN UNITED STATES—REFUSAL BY CORPORATION—POSITION OF MINISTER

Mr. A. D. Hales (Wellington): Mr. Speaker, my question is addressed to the Secretary of State who is responsible for the Canadian Broadcasting Corporation. It is a follow-up to a question I asked him earlier in the session dealing with the recovery of income tax from CBC employees stationed in the United States. My question is based on a written answer that I received from the minister wherein the hon. gentleman stated that the CBC has refused to collect this income tax as recommended by the Public Accounts Committee. I now ask the minister whether he is accepting the refusal of the CBC to make this collection or whether he is prepared to accept the recommendation of an all-party committee of this House?

Hon. James Hugh Faulkner (Secretary of State): Mr. Speaker, my position on this issue is as outlined in the letter to the hon. member. The suggestion I make in the letter is that the committee meet with officials of the CBC who say there is additional evidence they would like to place before the committee. I think this request is perfectly reasonable, and this is the course of action I would recommend.

**Mr.** Hales: In view of the fact that the minutes of proceedings of the committee for the last parliament have been finalized, and bearing in mind that this was the final decision of the committee, is the minister now prepared to accept the committee's recommendation?

Mr. Faulkner: My position is as I outlined.

EXPORTS OF SNOWMOBILES TO UNITED STATES— REQUEST THAT MINISTER EXPLAIN DECREASE

Referring to a reply appearing on page 2443 of the March 21 issue of *Hansard* concerning exports of snowmobiles, I note that 88,000 fewer units were exported to the United States in 1972 than in 1971. Can the minister tell the House whether there is any connection between the American take-over of our snowmobile industries and the decline of exports in that line?

Hon. Alastair Gillespie (Minister of Industry, Trade and Commerce): Mr. Speaker, I believe the main reason for the reduction in exports, though I should point out that there is still a very significant balance in Canada's favour, is that there were more manufacturers of snowmobiles in the United States, fewer people are buying them, and this year there was less snow.

As he knows, inquiries made by the Canadian Transport Commission are usually public and the reports are of a public nature, but there is a lot of routine investigation which is not made public. I think this is as it should be. I have asked the CTC to publish the results of certain inquiries they have made. I have also asked them, following the hon. member's reference, to attempt to find out whether there is some other way of discovering the chief causes of these accidents which seem to be too numerous these days.
