**Right Hon. J. G. Diefenbaker (Prince Albert):** Mr. Speaker, my question is directed to the President of the Treasury Board. About ten days ago, I think, I asked him a question concerning the undertaking apparently entered into by the Minister of Transport, and widely advertised in the press in Prince Albert during the by-election, which led to the general belief that between \$3 million and \$6 million would be spent on the Prince Albert airport. Has anything of this kind been brought to his attention and is it now before the Treasury Board?

**Right Hon. P. E. **MANPOWER****CANADA WORKS PROGRAM—REQUEST THAT HIRING AUTHORITY BE GIVEN TO MAYORS AS WELL AS MANPOWER OFFICES**

**Mr. Cecil Smith (Churchill):** Mr. Speaker, my question is for the Minister of Manpower and Immigration. I first want to assure him and the Prime Minister that no one in the Churchill constituency is living beyond their means. The unemployment rate in the Churchill constituency is in excess of 20 per cent. In order to qualify for the make-work programs, the unemployed must be hired through CMC offices. In many cases these centres are located hundreds of miles from communities. Will the minister give authority to the chiefs and councils, mayors and councils and community leaders who are better qualified to provide the placement of unemployed in their respective communities? Will he give them that authority to hire at the local level?

**Hon. Bud Cullen (Minister of Manpower and Immigration):** Mr. Speaker, I think the CMC is more or less the co-ordinating unit. I will look into the situation to see whether we can do an even better job than we have done in the past.

**ENERGY****PRICING AND TAXATION POLICIES FOR PRESENT AND FUTURE COMPANIES OPERATING IN THE TAR SANDS**
