#### GOVERNMENT ASSISTANCE TO MAINTAIN NEWFOUNDLAND RAILWAY—MOTION UNDER S.O. 43

In view of the enthusiastic and determined public meeting of 700 Newfoundlanders, held at St. John's Tuesday evening, including the MPs for St. John's West and Gander-Twillingate (Mr. Baker), five cabinet ministers of the government of Newfoundland, and some 20 members of the House of Assembly of Newfoundland representing all parties, representatives of the NDP and of the Newfoundland Federation of Labour and the St. John's city council, all of whom resolved unanimously that the Newfoundland railway continue in full operation, supported directly by funds from the Government of Canada and with new and invigorated management, and in view of the commitment contained in a telex message from the Secretary of State for External Affairs (Mr. Jamieson) that the government will grant direct financial support for the continued operation of the railway, I move, seconded by the hon. member for St. John's East (Mr. McGrath):

That the government pay all rigorously audited and proven losses of the Newfoundland railway each year and provide necessary capital expenditures and that the government instal active and aggressive business management dedicated to attracting business and competing, so that the jobs of several thousand Newfoundlanders and the rail mode of transportation in Newfoundland be maintained and strengthened.

In so doing, I would sincerely like to compliment the Minister of Employment and Immigration (Mr. Cullen) for the interest he has taken in this case and the telexes he has sent to Vienna in an effort to facilitate their entry into Canada, but at the same time strongly criticize Canadian bureaucrats in Vienna who are moving slower than the pace of a turtle in dealing with ministerial instructions.

I would move, seconded by the hon. member for Moose Jaw (Mr. Neil):

That in view of the dire straits in which this refugee family finds itself, in view of the fact that Canadian relatives have guaranteed to sponsor them financially in every way, and in view of the fact that Hungarian authorities are trying to entice them back over the border where they would be in severe danger, that the House appeals to the Minister of Immigration to issue an immediate ministerial order permitting entry to Canada of the Lantos family, thus enabling them to finally join in safety their relatives Mr. and Mrs. Larry Sherman of Brockville, Ontario.
