Hon. Pierre Bussières (Minister of National Revenue): Madam Speaker, if I remember correctly, unemployment insurance benefits paid to Indians who live on the reserve are taxable. Consequently, funds used to pay for the kind of projects the Hon. Member has just mentioned, funds that are paid out of the Unemployment Insurance Fund, would be taxable, while the additional amount to supplement the amount paid to a person as wages would not be taxable. In other words, there are two wage components, one from the Unemployment Insurance Fund, which would be taxable, and the wage supplement paid by another agency through the band council or another organization on the reserve, which would not be taxable.
