Mr. Deans: I hope the Hon. House Leader for the Official Opposition will not go away and stamp his foot in the corner. I want to make it clear that from the point of view of this Party, although the Bill is not all we would have wanted to see, it is better than what pertains at the moment. We are prepared to do what must be done in order to see it become law before the House rises for the summer.

Ms. McDonald: Mr. Speaker, I have a question for the Government House Leader concerning Bill C-19. Is it the Government's intention to bring in for debate at second reading the whole Bill, will it withdraw the Bill and bring in those parts for which there is agreement for speedy passage, or what?

Mr. Pinard: Perhaps the Hon. Member would see fit to raise the matter with her House Leader. We have already discussed it in a House Leaders' meeting. I intend to discuss it even further, if need be.
