

The question of concurrence being put thereon, the same was, on a division, passed in the negative.

The question being again put on the main motion, the same was resolved in the affirmative, and

The said Bill, as amended, was then read a third time accordingly.

The question was put whether this Bill, as amended, shall pass?

It was resolved in the affirmative.

Ordered, That the Clerk do go down to the House of Commons, and acquaint that House that the Senate have passed this Bill with several amendments, to which they desire their concurrence.

Pursuant to the Order of the Day, the Bill intituled: "An Act relating to Bills of Exchange and Promissory Notes in the Province of Prince Edward Island," was read a second time.

On motion of the Honorable Sir Alexander Campbell, seconded by the Honorable Mr. Smith, it was

Ordered, That the said Bill be committed to a Committee of the Whole House on Wednesday next.

The Order of the Day being read for the consideration of the Report of the Committee of the Whole House on the Bill intituled: "An Act to consolidate and amend the several Acts respecting the Inland Revenue."

On motion of the Honorable Sir Alexander Campbell, seconded by the Honorable Mr. Smith, it was

Ordered, That the said Report be not now considered, but that the Bill be again committed to a Committee of the Whole House presently.

The House, according to Order, was adjourned during pleasure, and put into a Committee of the Whole on the last mentioned Bill.

Ordered, That the One Hundredth and Forty-first clause be amended as follows:—

Page 53, line 26.—Leave out "or" and insert "and."

Ordered, That clause One Hundred and Forty-eight be amended as follows:—

Page 57, line 34.—After "returns" insert "penalties."

Page 57, line 35.—Leave out "six" and insert "seven."

Ordered, That clause One Hundred and Forty-nine be amended as follows:—

Page 58, Line 15.—After "accounts" insert "duties."

Ordered, That after the One hundredth and Sixty-first Clause insert Clause A.

*Clause A.*

*"Penalties.*

"Any person who after the passing of this Act, and without having a license under it then in force, shall carry on business as a compounder, shall for the first offence incur and pay a penalty of fifty dollars, and for a second or any subsequent offence shall incur and pay a penalty of two hundred dollars."
