#### USE OF CONFIDENTIAL MEDICAL RECORDS—CO-OPERATION WITH ONTARIO INQUIRY

**Mr. Bill Jarvis (Perth-Wilmot):** Mr. Speaker, my question is to the Solicitor General. It relates to the Ontario government's inquiry into the availability and use of confidential medical reports obtained from the Ontario Health Insurance Program. Is it the policy of the Solicitor General and the government to co-operate fully in assisting this Ontario inquiry?

Hon. Francis Fox (Solicitor General): Mr. Speaker, it is always our policy to co-operate fully with any provincial commissions of inquiry when they are referring to matters within their jurisdiction.

**Mr. Jarvis:** I welcome this good news about a change of policy. What seems to be at issue in the Ontario inquiry are the procedures used by security units representing various levels of government to obtain this confidential medical information. I therefore ask the Solicitor General if he intends to be forthcoming and open in providing the Ontario inquiry with the procedures and methods used by any security unit under his direction or control.

**Mr.** Fox: Mr. Speaker, there is only one security service under the aegis of the RCMP, and the hon. member knows full well which one it is. I can only relate that it is our intention as usual to co-operate fully with the legitimate demands of any

#### **UNEMPLOYMENT INSURANCE**

#### PROPOSED PROMOTION OF PROGRAM OF EMPLOYMENT RATHER THAN INSURANCE BENEFITS

Mr. Leonard C. Jones (Moncton): Mr. Speaker, my question is directed to the Minister of Employment and Immigration. Some years ago at a time of high unemployment a program was initiated in Moncton entitled "Do it Now". Subsequently there was a national program to encourage local citizens as well as business and all levels of government, to undertake necessary projects at home, in the office, in plants and in government, positively supporting the need for employment in areas such as the Moncton constituency and others in the Atlantic provinces. Would the minister now consider putting an immediate halt to the Unemployment Insurance Commission's promotion of UIC benefits and start promoting a program of employment to encourage citizens, corporations, governments, Crown agencies, Crown corporations to endorse work and employment projects by "doing it now" while men and materials are available?

# REFUSAL OF REPUBLIC OF CHINA TO EXTEND VISA OF JOURNALIST ROSS MUNRO—GOVERNMENT ACTION
