REPORTED REDUCTION IN BUILDING STARTS IN JANUARY

Since the government proposes to mark gage and Housing Corporation advise me been down slightly in the month of January -I have the figures before me-was the unusual high percentage of starts in the months of November and December to take advantage of the government's winter works incentive program.
