## PLATONIC LOVE

Prisoner's Strange Story at a Murder Trial in Syracuse.

Syracuse, N.Y., March 1.-Ernest Hecht, on trial for the murder of Mrs. Louise Foster, testified in his own behalf today. The prisoner told of meeting the woman, of their subsequent friendship and love. He maintained that their relations were The prisoner told of meeting the woman, of their subsequent friendship and love. He mairitained that their relations were platonic, and there was an irresitible affinity. The day previous to the tragedy she came to him, and said: "Ernest, now is the day we are to die." "I said," continued Hecht, "is there no help?' Mrs. Foster replied: 'No help, no help.' She said she would make all the arrangements for the double suicide. I tried to dissuade her, but in vain. She kissed me good-night, and said: 'Go to work tomorrow and keep cool.' I was miserable. At noon I called. She led me to the front room and said: 'This is where we are going to die.' I said: 'Why should we die?' and she answered: 'Because it is better so.' I returned later and asked her to go to the theater. She answered: 'Ernest, I will never leave these rooms alive.' I went out and bought something to eat and a red rose. She said: 'Have you come to stay?' I said 'Yes,' and she kissed me. I told her it was hard for me to die. 'Why must I go?' 'Because I go,' she answered. I got excited and said I would not die until she gave me a good reason. Then occurred such a scene as no man ever witnessed. All the furles in hell could not equal her denunciation of me, and her agonizing cries and walling. Finally she quieted and hugged and kissed me. She said: 'Are you ready?' and I responded. 'Yes,' Then she saturated a handkerchief with chloroform and poured out morphine pills containing 24 grains, and took them, handing me the vial to take the rest, and I did so. She lay down, placed the handherchief over her mouth and nose, and I became half dazed. I tried to write a letter to my brother, and spent the night in agony. I felt of her face and found it cold. I placed the red rose upon her breast and waited. In the morning Mrs. Wilbur came, then the police, and I was arrested.'' The recital was listened to by a crowd filling the court room. It was dramatic in the extreme.

## LAST WEEK IN THE OLD WORLD

Cabled Comment on European Topics---Critics Say War in South Africa Is on the Eve of Termination --- King Edward to Go Visiting Abroad---Gaiety Girl To Be Marchioness--- To Command the Royal Yacht.

Africa has reached a stage which the British newspaper critics call the eve of the termination. Rumors of the surrender of General Botha and the collapse of all Boer resistance flourish, to the great benefit of South African stocks. That those who are most responsible for carrying on the war do not share the optimism is perfectly evident from Mr. Brodrick's official utterances and the conversation of his colleagues, including Lord Roberts. Their carefully prepared campaign of thorough organization which has been quietly maturing during the past six months is beginning to have its first results, and they are perfectly satisfied. The new concentration of troops referred to so enigmatically by the correspondent at the front is only one of the many steps for which Gen. Kitchener has so long been preparing. That it will lead to the complete disintegration of more important Boer units, and, possibly, to the personal surrender of Generals Botha and Dewet, the British War Office earnestly hopes. Gen. Kitchener is almost as reticent towards his chiefs in Pall Mall as to the general public. When he has taken Gen. Botha into his camp, the war office expects to hear of it, but not before. As an official said to a representative of the Associated Press, grimly: "Armistices are not in Kitchener's line." The meeting of Gen. Kitchener and Sir Alfred Milner at Pretoria, probably occupying Sunday, is generally taken as likely to result in the estab-

lishment of a more permanent form of civil government, in which the severities of martial law will be somewhat tempered in several sections of the country. But neither in London nor in South Africa are the British officials shutting their eyes to the fact that they have a long job ahead of them, which can only be lightened, and by no means solved through the victories

BARON ALVERSTONE'S DEATH SENTENCE. Lord Chief Justice Baron Alverstone tonight for the first time in his career pronounced the death sentence. The man whom he condemned to the gallows is Herbert L. Bennett, 22 years old, who was found guilty of having strangled his wife with a shoe lace, at Yarmouth, last September. An attempt was made to prove an alibi, one of the witnesses for the defense, a reputable business man, testifying that he saw Bennett in London at the time the crime was committed. During the trial Bennett's counsel repeatedly attacked several London evening papers which had printed interviews with witnesses in the case, especially denouncing a New York reporter now employed on a London daily paper, and attributing all the newspaper interference in the case to the "Americanizing" of the English press." Baron Alverstone, in charging the jury, supported the attitude of counsel for Bennett, deploring the action of the newspapers. When the

verdict was pronounced, the prisoner again protested his innocence.

BRITISH POLITICS ARE DULL. While the war in South Africa 13 no longer a current topic of conversation, nothing has taken its place. The China settlement does not interest the public, even when Dr. Morrison asserts that a policy of partial partition has begun with the delivery of territory to Russia, and that more than one power besides Japan and England has demonstrated vigorously against it. Anglo-American relations excite no comment from the press, although the foreign office is ap-parently allowing the canal treaty to lapse without a word, unless there is some surprise in reserve for Washington over Sunday. The debates in parliament were never duller, and there are no questions of national politics in which the electors are deeply interested. The Maidstone election is a proof of stagnation in politics outside of London. Today's contest over the London county council is chiefly remarkable for the holding aloof of Conservative voters, who are in revolt against the water lords. GERMANY PROHIBITS CAPE TOWN IMPORTS.

Before the budget committee of the Reichstag, Baron Von Richthofen, secretary of the foreign office, announced that a decree would be issued today prohibiting imports from Cape Town, owing to the existence of the plague there. Fifty-six claims of German employes for the Transvaal railroad, who had been expelled from that country, were submitted to Great Britain, who had declared herself to be ready, in principle, to compensate them for losses. A special German delegate will be a member of the committee appointed to determine these and similar losses.

MOVEMENTS OF ROYALTY. Interest in the new reign will revive when the King returns, and this is the most cheerful topic of the time. There being received in the throne room. There are rumors that the King will soon make another foreign journey, but these are clearly premature. Many details of the journey of the Duke of Cornwall to Australia and Canada still require revision, and there are many state affairs under consideration, including the appointment of a successor to the Bishop of London and the settlement of the civil list. The prime minister really makes that important Episcopal appointment, but the King's wishes will presumably be ascerportant Episcopal appointment, but the King's wishes will presumably be ascertained and followed. The Bishop of Winchester enjoyed the friendship of Queen Victoria, and his transfer to London would be natural if his health were equal to the enormous labors of the metropolitan see. The rumor that Dr. Weldon, Bishop of Calcutta, will receive the appointment hardly seems credible. He was a successful head master at Harrow. The schoolmasters have been the preferred candidates in recent times for Episcopal promotion, but he has scarcely more than begun his work in India, and Episcopal promotion, but he has scarcely more than begun his work in India, and his recall would be premature. The Bishop of Chester is also prominently mentioned as a candidate, while the position of the Bishop of London is rendered well-nigh impossible by the conditions of the ritual controversy in the Established Church. It carries the presumptive right to the succession to the See of Canterbury, and cannot be lightly declined.
