UNITED NATIONS—INTERGOVERNMENTAL

1. The convention of the intergovernmental maritime consultative organization has not yet come into force because it has not been ratified by the required number of countries. However, a preparatory committee of the intergovernmental maritime consultative organization is in existence; and the chairman of the Canadian maritime commission, Mr. J. V. Clyne, is chairman of the preparatory committee.

CLAMS—ANNAPOLIS BASIN—PROHIBITED AREA

1 (a) All the waters of Annapolis basin from a point on the western shore line due east of The Pines hotel to Robertson Point situated $1\frac{1}{2}$ miles northeast of Little Joggin railway bridge, including the Racquette, the town of Digby water front and the Little Joggin.

(b) That portion of the south shore of Annapolis basin lying between Deep Brook stream and Roop Brook, Clementsport, including the vicinity of Deep Brook naval base and the mouth of the estuary of Moose river.

2. The above areas are closed by authority of section 5, subsection 5, of the special fishery regulations for Nova Scotia and the Fisheries Act, 1932.

3. Tests are not made of the soil but of the waters where clams are dug. Tests for toxicity are also made on samples of clams from the areas in question.

4. During 1948, Inspector L. R. Comeau. During 1949, Inspector G. M. Bullerwell; Inspector P. E. Filleul.

5. During 1948 from Racquette and Clementsport. During 1949 from Smith's Cove and Clementsport.
