INCREASING USE OF HEROIN IN ONTARIO CITIES— DISCUSSION WITH ONTARIO OF JOINT PROGRAM TO COPE WITH PROBLEM

Mr. David Orlikow (Winnipeg North): Mr. Speaker, I should like to direct a question to the Minister of National Health and Welfare. In view of very serious drug problems, particularly the widespread use of heroin in Ontario cities as indicated in the report prepared by a committee appointed by that department, is the department taking steps to discuss with the government of Ontario the planning of a joint program in order to deal with this situation?

Hon. John C. Munro (Minister of National Health and Welfare): Mr. Speaker, I appreciate the hon. member's question. This report has just recently come to my attention. There is no doubt that not only in Ontario but in other provinces there is mounting evidence of increasing inflows of heroin and of people resorting to its use. We have endeavoured to upgrade, on an emergency basis, various aspects of our drug abuse program. As we analyse the findings we are certainly entertaining a course of action such as the hon. member has suggested.

Mr. Orlikow: Mr. Speaker, I am not critical of the number of expensive studies undertaken by the minister's department, but there is not much point in carrying out studies unless they are followed by action. Will the minister consider discussing what can be done about this very serious problem with the province of Ontario and other provinces?

Mr. Munro: I have already answered the hon member, Mr. Speaker, that we are considering adopting that very course. These studies can be justified by the fact that we have already expended considerable money to combat this problem. These studies have indicated to us how this money can be most usefully directed.

PULP AND PAPER—PROVISION OF EMPLOYMENT SUPPORT PROGRAM

Mr. Jack Marshall (Humber-St. George's-St. Barbe): In view of the reported widespread lay-offs throughout our economy, particularly in the pulp and paper industry, which are beyond the scope of the Employment Support Act, will the Minister of Industry, Trade and Commerce advise the House whether the government intends to introduce a comprehensive employment support program to overcome this disaster?

Hon. Jean-Luc Pepin (Minister of Industry. Trade and Commerce): Mr. Speaker, in respect of the pulp and paper industry singled out by the hon. member, I have already indicated a number of things that are being done at the federal and provincial levels, in the case of Quebec. A few days ago I indicated to the hon. member that we were looking into other possibilities. I also indicated that a meeting is to take place between the leaders of that sector of Canadian industry and members of the cabinet.

Mr. Marshall: Mr. Speaker, could the minister advise whether these support or relief programs will include assistance to the pulp and paper industry in respect of the \$700 million cost of anti-pollution measures and other types of programs?

Mr. Pepin: Mr. Speaker, I have already indicated that some of the measures announced in the last budget would accomplish this, as well as some measures being taken by the Quebec government. I have indicated also that we are looking into other ways of helping in this very difficult situation. My hon. friend is perhaps aware of the fact that the pulp and paper industry is picking up a little. Sales in August were 3 or 4 per cent higher than they were last year at the same time, and with regard to the United States they were 9 to 10 per cent higher than they were in August last year.
