REPORT OF JOINT STUDY GROUP ON BASIC RATE OF DISABILITY PENSION—INQUIRY AS TO IMPLEMENTATION BEFORE EASTER

Mr. Stanley Knowles (Winnipeg North Centre): Mr. Speaker, my question is for the Minister of Veterans Affairs and it relates to the report of the joint study group on the basic rate of the war disability pension, which was endorsed unanimously by the Standing Committee on Veterans Affairs. Can the minister say when the bill implementing this recommendation will be placed before parliament?

Hon. Daniel J. MacDonald (Minister of Veterans Affairs): Mr. Speaker, this report has received some study by the government and it is coming back again on April 16. We planned on getting it there before that, but due to other matters that needed to be taken care of previous to that time we were not able to do so. As I say, it will be before the government again on April 16, and if I have the permission of the government I hope progress will be made on the report and that we will be able to proceed with the enactment of legislation.

Mr. Knowles (Winnipeg North Centre): I have a supplementary question, Mr. Speaker. In view of the likelihood that such a bill would receive quick passage by the House, will the minister make every effort to get it to us before Easter?

Indeed, I can tell the House that the Canadian Wheat Board is very carefully assessing not only our own future needs but the regular supplies which our very good customers count on receiving from us, and are planning their sales accordingly. The Canadian Wheat Board is continuing to make forward sales of wheat in view of the supplies we have on hand.
