Mr. Lewis: Mr. Speaker, mine was a very carefully prepared speech—

Mr. Lewis: I became somewhat excited by the complete lack of responsibility shown by my colleagues across the way. I appreciate having had the opportunity to contribute to this debate.

Mr. Len Hopkins (Renfrew-Nipissing-Pembroke): Mr. Speaker, there seems to be some confusion with respect to what the Bill before us is all about.

An Hon, Member: You are confused.

Mr. Hopkins: I would like to set Hon. Members straight. Bill C-79 is an Act respecting the provision of compensation to depositors of Canadian Commercial Bank, CCB Mortgage Investment Corporation and Northland Bank in respect of uninsured deposits, as my hon. friend from Ottawa-Vanier pointed out to the previous speaker.

The previous speaker said that he had a well prepared speech. I would hate to hear one that is not prepared.

I would like to straighten out another matter as well. The Hon. Member for Lévis (Mr. Fontaine) also spoke in this debate. He said: "We Conservatives are talking about \$470 million while the Opposition is talking about a \$1 billion bail-out." I think it behooves the Conservative Government at least to have its members read a Bill before they get up in the House to speak about it. Clause 16 of the Government's Bill reads as follows:

There is hereby appropriated, for the purposes of this Act eight hundred and seventy-five million dollars to be paid out of the Consolidated Revenue Fund from time to time as required.

Yet, the Hon. Member stands up and says: "We Conservatives are talking about \$470 million." How phoney can one get?

I would like to put another fact on the record. No list of depositors has been granted to the Members of this House before the Bill came before it for discussion. Indeed, no list was granted before the time allocation motion was moved.

We have no information with respect to the Northland Bank. I would remind all Hon. Members of the House that we as Members of Parliament sit here because we must be accountable to the taxpayers of the country. We do not sit in the House to vote blindly for something which is not explained in principle nor, indeed, spelled out as being a Bill with respect to uninsured depositors in these banks.

I would also remind the Government that it was a Bill of the Liberal Government presented approximately five years ago which raised the limit on insured loans in the banks of Canada from \$20,000 to \$60,000. This Government now comes in and, holus-bolus, takes in everyone. All of us must be accountable to the taxpayers of this country and I hope that Hon. Members of this Government are prepared to go out into their own constituencies and explain to the senior citizens and those families with children why their tax deductibility was taken away from them. I hope those Hon. Members can explain why they are bailing out the rich and the wealthy.
