EXTRADITION ACT

MEASURE TO AMEND

Hon. Monique Vézina (for the Minister of Justice) moved that Bill C-31, an act to amend the Extradition Act be read the third time and passed.

Mr. Rob Nicholson (Parliamentary Secretary to Minister of Justice and Attorney General of Canada): Mr. Speaker, on September 17, 1991 the Minister of Justice tabled in the House of Commons Bill C-31, which is the culmination of efforts to reduce the inordinate delays that are currently possible in extradition cases.

The need for the amendments contained in this bill, I would suggest, is urgent. Canadians are deeply concerned about the legal system operating as an impediment to Canada being able to return persons wanted for trial or sentence to foreign jurisdictions.
