At last night's meeting a report as to the condition of a number of these wooden shacks was presented from the sani-tary and building inspectors. The report was adopted and an inquiry will be held to allow of owners being present to show cause why they should not be destroyed forthwith. The buildings ondemned are: One story building next the Balmoral hotel on View street, owned by Mrs. Annie M. Brown, used as a storehouse: two old wooden buildings east of the Balmoral hote', owned by George Mellor, used as store ouses; an old half burnt building on lot 405, block 13, Fort street; three wooden sheds and a stable on lot 1247,
