Mr. Kierans: Not a word, Mr. Speaker.

Mr. Sieven E. Paproski (Edmonton Centre): I have a supplementary question, Mr. Speaker, which I should like to direct to the Minister of Labour. On March 18, as reported at page 6742 of Hansard, the Postmaster General replied in the affirmative when he was asked whether "the services and the ability of his colleague, the Minister of Labour, are being used" in the handling of the postal dispute. My question is this: When does the minister intend to dissociate himself publicly from the arrogant and high-handed labour tactics of his colleague the Postmaster General?

Mr. Speaker: Order, please.

Mr. Stanfield: A supplementary question, Mr. Speaker. Did the Postmaster General mean to indicate that he had asked through the appropriate channels for this report before July 4, that he had failed to get a copy and that one was withheld from him until July 4?

Mr. Kierans: Mr. Speaker, from the beginning of May I kept asking how long it would take to get the adjudicator's report. From then on I kept asking whether the adjudicator's report was in yet, and so on. That is exactly what I meant by my reply.

Mr. Stanfield: A further supplementary question. To whom did the minister direct his inquiries, and what reasons were given for the delay?

Now that it appears that the house itself will not have an opportunity to discuss this matter, will he take the initiative to have this newly revealed report, which must have been sent by mail, referred to an appropriate standing committee before negotiations begin, so that the committee may look at the report?
